We heard from former Orlando Magic player, Nick Anderson, who talked about how he was deeply impacted by violence as a teenager. We also heard from Rachel Sines, a former VSC client, and her husband, David, who shared the

story of her assault and how it not only impacted her, but also greatly impacted his life. Our MC for the event, Carlos Navarro from Real Radio 104.1, shared his story and did a fantastic job engaging the audience.

# VSC & OPD Launch Safety Campaign



On February 19th, VSC teamed up with the Orlando Police Department to promote safety in Downtown Orlando. The campaign, targeted at the downtown nightlife, is aimed to prevent sexual violence. VSC and OPD will be putting up posters in downtown bars and nightclubs promoting active bystander intervention in an effort to reduce sexual assaults.

At VSC, 33% of sexual assault cases involve drugs or alcohol. The unfortunate reality is that perpetrators prey on the weak and defenseless. Alcohol is one common way to incapacitate and take advantage of a victim. At VSC, we encourage our community to watch each other's back and look out for your friends. well as military veterans. Kristen hopes to empower clients to help them see their own strength and resilience.
