# **Amanda's Story**



I am writing this letter in hopes of helping others like me have the resources available to them that I had.

When I was a child, I felt I lived on a different plane than other children. My hazy existence was brought on by my abusive father, who regularly forced his ideals of what a "special" father-daughter relationship should be. I was sexually,





physically, and emotionally abused as well as degraded, berated and forced to suffer through his treacherous fantasies. He used drugs and alcohol to help attain what he wanted from me as I got older and started to resist. He used lies and threats to keep me compliant, making me believe that this is just how life is for every girl.

I survived. I made it through the abuse and aftermath, thanks to my animals and my ability to daydream of happiness and security. I felt that I was doing just fine, living in denial for many years.

However, in 2008, memories started to resurface. I felt I was reliving my childhood every time I attempted to sleep. Anxiety crept into my life and insomnia ruled my nights. <u>Continue</u> <u>Reading</u>

# **Untested Sexual Assault Kits**



On January 4th, the Florida Department of Law Enforcement (FDLE) released the Sexual Assault Kit Assessment regarding the 13,000 untested rape kits. They conducted a statewide assessment of the kits that had not been submitted for analysis.

Channel 2, Channel 6, and Channel 9 all stopped by VSC's offices to get our input on the report and to learn more about that process. VSC's Executive Director, Lui Damiani, said,

"Getting justice is a big part of some victim's recovery. What we don't want to do is have any unintended consequences that has fewer people coming forward, seeking help."
